Proposals will be reviewed based on:

- Ability to meet the needs of the event
- Experience with outdoor production and A/V support
- Quality and reliability of equipment
- Staffing and technical support capacity
- Overall cost and value
- Availability for July 4, 2026
- References and past event experience
